Who We Are (Data Controller)

Installation may be carried out by approved installers, however EcoFrame Direct remains the data controller unless otherwise stated.

What Personal Data We Collect

Information you provide directly:

Where Your Data is Stored

Data is stored on secure UK servers, cloud services, email systems and CRM platforms. All providers follow GDPR compliance requirements.

How Long We Keep Your Data

- Enquiries: up to 12 months
- Quotes: up to 3 years
- Installation records: 10 years (warranty requirement)
- Finance queries: as required by Kanda/FCA rules
